4. AGM talking point, Yearly Dinner Planning. Discuss the 2024 Yearly Dinner. Confirm the Vice Chairperson's attendance and responsibilities for running the event (Chairperson will be unavailable in the USA). Review the proposed date and venue (ideas, venue at either Plymouth Bowling Green on Plymouth Hoe, Crown Plaza Plymouth Hoe, The Dome Plymouth Hoe, Last year's venue The New continental, or HMS Drake WOs & SRs mess) and other ideas are very welcome.

The meeting's agreement was that the vice chairperson would explore the possibility of hosting the 2024 annual dinner at the Crown Plaza in Plymouth. This event could potentially align with Remembrance Weekend, taking place from November 8th to 11th, 2024. It might include a distillery tour at Plymouth Gin on Saturday, the ASW dinner in the evening of November 10th, and a Remembrance Day parade muster on Plymouth Hoe on November 11th.

**5. AGM talking point. Engaging Junior Sailors.** Explore strategies to increase interest among junior sailors to join and attend dinners and social events. Brainstorm ideas for making these events more appealing to junior members.

In order to promote participation in ASW Association events among junior sailors, we have appointed Mr. Glenn Cameron as the ASW Association's liaison officer for junior ratings. He will serve as a contact person for inquiries related to formal matters, personal issues, and the discussion of upcoming events that junior sailors can organize.

**6.** AGM talking point, Volunteer Committee Positions. Discuss the need for volunteers to fill committee positions. Review current positions and responsibilities. Encourage members to express interest or nominate others.

The ASW association has successfully placed volunteers in various committee positions, ensuring a strong and diverse team. This will enhance our ability to organize social events, share ideas from current Royal Navy members and veterans, and reach a broader audience. We extend a warm welcome to all our new volunteers, as you are the future of our esteemed association, and we look forward to the positive impact you will make.

7. <u>AGM talking point,</u> Junior Sailor of the Year Award. Discuss the continuation of the Junior Sailor of the Year Award. - Clarify eligibility and criteria for UW Junior Sailors across the UW Community.

This year, as a committee, we made a collective decision to encourage greater participation of Junior members currently serving in the Royal Navy within the ASW association. To accomplish this goal, we introduced the concept of recognizing an ASW association sailor of the year. In my unique role as a liaison between active RN sailors, I reached out to all current FFTA's and requested nominations from their commanding officers for individuals who have made exceptional contributions and demonstrated a strong work ethic in ASW operations. Our intention is to extend this recognition to all Junior members within the Underwater Warfare Community for next year's award, with the hope of inspiring future generations and my relief in the future.

**8.** AGM talking point. Stock Take and Merchandise. Conduct a full stock take of current association merchandise. Discuss the intention to order new hats, polo shirts, and cumber-bands. Plan to create a poll on the ASW Association Facebook page to gauge interest in these items or other members ideas.

Following the conversation about the ASW association's stock levels and current merchandise inventory, Mr. Bob Burton mentioned that Forever, Jack's website is the repository for all our crests and offers customized clothing and gifts.
